Initial Safety Plan

The purpose of this plan is to ensure the safety of Cash R. Goldhammer, Blakelynn R. Burnham, Barrow J. Burnham, Bo Burnham, Jaxon L. Goldhammer, Rowen A. Wakefield, Hudson L. Wakefield, Rylee A. Goldhammer, by managing the safety threats within the family.

Safety Threat(s):

Explain the Safety Threats that necessitated the Initial Safety Plan:

#3 - impulsivity.

Nicole struggles with current unmanaged mental health issues. Her behaviors are increased around the birth of Bo on 3/20/2025. Nicole recently reported that she felt like she wanted to end her life due to her circumstance. She has had ongoing concerns for her mental health that has gone untreated and has impacted her ability to safely parent her children. The familial situation is also only active while she and Matthew are in the same area as their relationship is currently under duress.

Plan to manage safety threats, including how the plan will be monitored:

This is a in-home plan for Cash, Rylee, Jaxon, Rowan, Hudson, Barrow, Blakelynn, and Bo. The children's safety is currently being monitored by safety service providers listed below as well as through a minimum of weekly face to face contacts made by the assigned worker, Alicia Davis.

No safety service providers are needed while the children are in the care of their fathers, Matthew Burnham (971.491.6058), Alex Wakefield (503-676-9003), and Anthony Goldhammer (503-320-1524)

Alex Wakefield will have Rowan and Hudson in his care, at his home, according the their custody agreement or mutually agreed upon time.

Anthony Goldhammer will have Cash, Rylee, and Jaxon in his care, at his home, according the their custody agreement or mutually agreed upon time.

Matthew Burnham will have Bo, Barrow and Blakelynn in his care, at their paternal grandmothers home, according the their custody agreement or mutually agreed upon time.

Nicole will have Bo, Barrow, Blakelynn, Hudson, Rowan, Jaxson, Cash and Riley in her care, at her home, according the their custody agreement or mutually agreed upon time.

Safety service provider Kerri Burnham (503.757.4047) agrees that if she volunteers to monitor the safety and well being of the children while both Nicole, Matthew, and child/ren are present, she will remain with the children the entire time until one of the parents are no longer present.

Safety service provider Aidan Hughes (503.935.7742) agrees that if she volunteers to monitor the safety and well being of the children while both Nicole, Matthew, and child/ren are present, she will

remain with the children the entire time until one of the parents are no longer present.

Safety service provider Jean Baker (971.274.8551) agrees that if she volunteers to monitor the safety and well being of the children while both Nicole, Matthew, and child/ren are present, she will remain with the children the entire time until one of the parents are no longer present.

Safety service provider Elliott Baraby (971.400.7797) agrees that if he volunteers to monitor the safety and well being of the children while both Nicole, Matthew, and child/ren are present, he will remain with the children the entire time until one of the parents are no longer present.

Greater New Hope workers will do 3 daily unannounced check-in's at Nicole's home, to ensure that Nicole and Matthew Burnham isn't having contact with each other with the children present, without the above mentioned safety service providers present.

Please call the caseworker during normal business hours or the Child Abuse Hotline afterhours if:

- You have observed or have knowledge of Matthew and Nicole Burnham are residing in the same home or together with the children present without a safety service provider that is listed above
- You have observed or have knowledge of Matthew and Nicole Burnham engaging in yelling, hitting, kicking, slapping, or any other aggressive/assaultive behavior within earshot, in the presence of, or around any of the children
- You have observed or have knowledge of Nicole self-harming or threatening self harm while in the presence of her children
- You have reason to believe Nicole maybe in mental health crises while caring for her children Symptoms and signs could include erratic behavior, unable to have rational conversations, excessively crying to where she is unable to meet the children's basic needs.

***If the safety service providers feel that mothers behaviors are detrimental to the children's safety and well being, they are to remove the children from the mothers care and get them somewhere safe, call 911 or Multnomah County Mental Health Crises Line (503.988.5887), and then call the fathers to come get the children while waiting for law enforcement or mental health crises team to respond.
